RELEASE FORM, AGREEMENT REQUIRED

I, the undersigned, knowingly and without duress, do voluntarily submit this form to the Shenandoah Taijiquan Center/Winchester Yang Chengfu Tai Chi Chuan Center concerning the Events of **YANG FAMILY TAI CHI CELEBRATION WINCHESTER 2020**. I do hereby assume all risk of personal, physical or mental disabilities, injuries or losses, which may result from participating in these Events, and acting for myself, my heirs, personal representatives, and assignees, I hereby release A Taste of China, Inc., Shenandoah Taijiquan Center/Winchester Yang Chengfu Tai Chi Chuan Center, International Yang Family Tai Chi Chuan Association, Shenandoah University, their instructors, their officers, agents, representatives, servants, employees, and all other related members from all claims, actions, suits, controversies, claims at law or in equity by reason of any matter, cause or thing whatsoever, that may hereafter sustain. I hereby represent that I am physically fit to engage in the instructional training, and that above mentioned entities are under no obligation to require proof to this fact. I hereby acknowledge that I fully realize that during the classes I will always be able to withdraw from participation in any exercise or technique, and that it is my personal responsibility to decide exercises or techniques to participate in. I also understand that there is risk of injury in all training and I assume full responsibility for all my actions, during and in connection with said Events. If my actions, conduct, or statements while participating in or attending the Events are determined to be inappropriate or detrimental to the safety or well-being of other participants or instructors, I shall willingly comply with the request of the director or his/her agents, that I remove myself and my effects from the site of the Events immediately. I realize and agree that I will forfeit any prepaid fees if requested by the director or agents to terminate my participation in the Events. I agree for myself, my heirs, personal representatives, and assignees that the above representations are contractually binding, and that I, my heirs, personal representatives, and assignees assert any claim in contravention of this agreement, I, my heirs, personal representatives, and assignees shall be liable for the expenses incurred by the other party or parties in defending unless the other party or parties are adjudged liable on such a claim for willful and wanton negligence.
